

PUBLICATION OF DATA RELATING TO SHORT-TERM RENTALS (B & B)

The beginning and end of each use must be promptly communicated to the administrator using the section on this page. The form must be filled out 48 hours in advance of enjoying the places (a receipt of completion will be produced by the site). The form proposed on this page must be completed by the owner of the real estate unit or by a person delegated by him to manage the rental.

Sanctions

It is specified that for infringements of this regulation it is equated to failure to comply with any other rule established by the condominium regulation and is proposed as a sanction for the payment of a sum of up to € 200.00 and in the event of a repeat offense up to the € 800.00 (article 70 of the implementing provisions of the civil code).

If the short-term rentals lead to uses that are contrary to public order and morality, the condominium will promote the necessary reports to the police through the administrator.
